The hearing pertains to Zone Change No., PZC 23-011 to change the zoning from AE-10 (Exclusive Agricultural – 10 acre minimum) Zone to R-A-43 (Rural Residential – 43,000 square foot minimum) Zone and Tentative Subdivision Map No., TSM 23-009 to divide the 18.19 acre parcel into ten (10) parcels ((Parcels 1-8 will be approximately 1.01-acres in size, parcel 9 will be 1.58-acres, and parcel 10 will be 7.84-acres). The subject site is located on the north side of Monson Drive and approximately 450 feet southwest of Simpson Road within the Monson Hamlet Development Boundary. The site is within Section 35, Township, 16 South, Range 24 East, MDB&M (APN: 033-050-002). Under the California Environmental Quality Act (CEQA), a Categorical Exemption which is consistent with CEQA and the State CEQA Guidelines pursuant to Title 14, Cal. Code Regulations, Section 15303, Class 3, pertaining to New Construction or Conversion of Small Structures, as each of the proposed parcels would allow for a minimum of one (1) residence to be constructed.




